NOTES:

- The ranked project were scored/rated and ranked according to the City of New Bedford's Ranking and Review process outlined in the 2018 RFP and made available at www.nbhspn.com.
- In accordance with the 2018 CoC NOFA, the ranking follows a two tier system such that Tier 1 = 94% of the Annual Renewal Demand (ARD) and Tier 2 = the difference between the ARD and Tier 1 plus bonus.
- The amount of funding available for a permanent housing bonus in this 2018 round was \$118,668, however, no applications were received for new permanent housing.
- The amount of funding available for a DV Bonus project in this 2018 round was \$197,780. One new DV Bonus project was submitted and ranked in this round.
- The projects identified under Tier 2 include the bonus DV project.
- The CoC intends to submit a planning grant in the 2018 round that will, in accordance with the CoC NOFA, remain unranked.

According to the U.S. Department of Housing and Urban Development, a DV Bonus project's ranking on the priority listing will not affect its likelihood of being selected. Whether the project is ranked first, last, or somewhere in between, it has the same chance of being selected under the DV Bonus.

This FY18 Final Rank and Order of Projects was presented by the New Bedford CoC's (HSPN) Performance Review Committee at the August 16, 2018 HSPN Meeting.
